Advanced Amphibious Assault (DRPM AAA) program office has a requirement for comprehensive engineering, logistics, acquisition and technical analysis services to support the development, production and fielding of the Advanced Amphibious Assault Vehicle (AAAV). Offerors should possess major weapons system related engineering, logistics, acquisition and technical analysis support services experience in support of a major program office. Prospective offerors must have facilities or be willing to establish facilities within 20 miles of the DRPM AAA facility located at the Worth Avenue Technology Annex (WATA), 14041 Worth Avenue, Woodbridge, VA 22192-4123.
